- **1. Scope:** Assessment and verification of the manufacturing process of the pressure equipment covered by the Directive 2014/68/EU
- 2. Reference documents: AD2000 Merkblatt HP0 issued October 2017
- 3. Conditions for validity of the certificate:
 - 3.1 During the period of validity of the certificate, the ordering part will be:
 - maintained compliance with the requirements of the specification referred to in the certificate and documentation.
 - informed about any changes, in particular regarding the location and scope of operation
 - kept records of all complaints as well as corrective and preventive actions
 - 3.2 During the validity period of the certificate supervision will be exercised by UDT CERT according to planned supervisions audits.

 - Preventing the inspection by the customer.
